**Q12. Please provide comments on any other improvements you would like to see occur with the UK Hemp PT program.**

Q12. 105 1.We saw a trend that the moisture content of each sample increased over time. It might be related to the samples being in a bag with a zip closure instead of a jar or a more airtight container. 2. An idea is to add a version number or date associated with the method code list. That way we know if we should re-check the list or use our same codes from last time. For example, we are currently reporting several methods as “other,” so we would need to review the list if any additional codes are added to see if our methods match the newly-added codes.

Q12. 106 No opinion

Q12. 107 Just better readability on the website primarily.

Q12. 108 Only allow the selection one method code and not have a method code for each analyte. Its assumed a lab will use one method for all analytes. This will simplify reporting. Also it would be helpful to send out the reports in an email to the labs instead of logging into a portal. Accreditation bodies also like to see an issuance of pass or fail which these PTs do not have that. Also four different samples requiring triplicate runs seems a little excesses. Make the Total THC concentrations closer or at the legal limit of 0.3% which is the range of accuracy which is most important.
