The one-half cent (\$0.005) per hundredweight (cwt.) inspection fees are required by KRS.260.820. The intent of this section of the Kentucky Farm Milk Handlers Law is that all milk received by Kentucky processors (regardless of source) and all milk marketed by Kentucky producers shall be accounted for and assessed an inspection fee. The inspection fee, in part, provides funds for the implementation of the Kentucky Farm Milk Handlers Law. The fees are intended to be an equally shared cost between Kentucky processors and producers.

Information for your firm should be reported within the table(s) on the back of this form. Table 1 is to be used only by handlers who issue payments to Kentucky producers. Table 2 is to be used by processors located within Kentucky. In some instances, handlers may be required to complete all tables. **This inspection fee report must be completed even if you report "zero".**

Due dates for each quarter are identified below. Reports not postmarked by the delinquent date shall include a penalty of twenty-five dollars (\$25.00) or ten percent (10%) of the amount due, whichever is greater.
